CERB fraudsters could face fines or jail time

Fraudulent CERB claims and the government's ability to track down and enforce penalties on Canadians who are intentionally scamming the system has been an ongoing issue since the program first rolled out. Canadians who make fraudulent claims for the Canada Emergency Response Benefit (CERB) could face a fine of up to \$5,000 (in addition to paying back the benefit) and jail time, according to a draft bill. On June 1st, the CRA updated its National Leads Program website to advise

Canadians that the program can currently accept leads from Canadians who wish to <u>report suspected</u> <u>fraudulent applications for the CERB</u>. This program gives you the opportunity to anonymously report suspected domestic tax evasion online, or by phone, mail, or fax.



Why you need a will

Having an up-to-date will is essential to make sure your estate is distributed as you intend it. If you die without a valid will, your estate will be distributed according to provincial laws. <u>These</u> are a few disadvantages of dying without a will. How to get help if you owe taxes and can't pay

You can ask the CRA to <u>cancel or waive penalties or interest</u>if you couldn't file your 2019 tax return by June 1, 2020 due to COVID-19 and/or you cannot make tax payments by September 1, 2020. The best way to submit a request is online and there is certain <u>information you must include with your request</u>.
